# Announcement of Balloting

## 2025 Election of 1199SEIU Officers, Organizers, Executive Council Members and Delegates

### MAIL BALLOT ELECTION<sup>1</sup>

In April 2025 the 1199SEIU Election Board will be conducting elections for officers, organizers and rank and file Executive Council members. Balloting will be by mail under the supervision of the American Arbitration Association (AAA). The mail ballot will insure that every member will be able to vote.

### DATES OF ELECTION

The AAA will mail the ballots to all members on **Tuesday, April 1, 2025**. All ballots must be mailed back and received by the AAA no later than 5:00 p.m. on **Wednesday, April 30, 2025**. No hand delivered ballots will be counted. Ballots returned after the deadline will not be counted. **If you do not receive a ballot by April 9, 2025, call the AAA at 800-529-5218, Monday-Friday, 9:00 a.m. - 5:00 p.m., to receive a ballot packet.**

You will also be voting for delegates during the month of **April 2025** in your institutions and departments. Your organizer will advise you of the dates of these elections.

### CERTIFICATION OF CANDIDATES

The Election Board will issue initial eligibility determinations of candidates by **March 3, 2025**. Challenges to the Election Board's initial eligibility determinations must be filed in writing by **Thursday, March 6, 2025** with Assistant to the Election Board Maceo Torres-Trujillo at 498 7th Avenue, 24th Floor, New York, NY, 10018 or by email at [Maceo.Trujillo@1199.org](mailto:Maceo.Trujillo@1199.org). See the Rules for Challenges for further instructions, available at all petitioning locations or by contacting the Assistant to the Election Board.

The Election Board will issue final certifications of candidates by **March 11, 2025**.

### INSPECTION OF VOTER LISTS

The list of eligible voters is available for one-time inspection (not for copying) by candidates **through March 31** at 1199SEIU headquarters or regionally

## **DISTRIBUTION OF CAMPAIGN LITERATURE**

The Union will send campaign literature to the membership or to a portion of the membership (if such limited distribution is practicable) on behalf of any candidate. The candidate will be required to pay in advance all costs which will be incurred in connection with such distribution. Requests for distribution should be submitted in writing to the Assistant to the Election Board (see contact information listed above).

## **FORM OF BALLOT**

As in past elections, members will be able to cast ballots for an entire slate or for individual candidates running as independent candidates or running as part of a slate. Please keep in mind, however, that if you vote for an entire slate you should not cast an additional vote, unless there is no candidate running for that position on the slate for which you voted. (You may not vote for more than the listed number of candidates for each office.) As in past elections, slate votes will take precedence—in other words, if you vote for a slate and additionally vote for an individual candidate for an office in which the slate has a candidate, the additional vote will be invalid.

## **BALLOT COUNT**

The Election Board will oversee the AAA's counting of ballots on **Saturday, May 3, 2025** at the offices of the 1199SEIU Funds. All candidates are permitted to observe in person or may designate a member to observe on their behalf. Due to space limitations, non-candidates are not permitted to attend the ballot count with the exception of members who are designated as observers by a candidate. There will not be virtual observing.

## **ELECTION RESULTS**

The Election Board will meet after the ballot count

and announce the Election results to the candidates. Results will also be posted on the Union's website, [www.1199SEIU.org](http://www.1199SEIU.org), and made available upon request to any member. Please call or email the Assistant to the Election Board.

## **ELECTION OBJECTIONS**

Objections to the election must be received by the Election Board in writing by **May 13, 2025**. Objections should be submitted to the Assistant to the Election Board.

## **NO USE OF EMPLOYER OR UNION RESOURCES**

As stated in the Initial Election Announcement, 1199's Officers election is governed by Federal law, which prohibits the use of Union or Employer resources to promote or oppose any candidate in the election.
